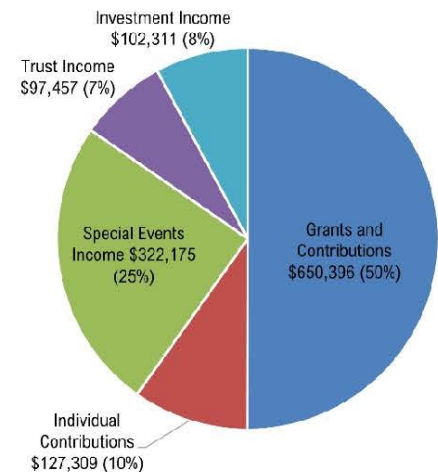

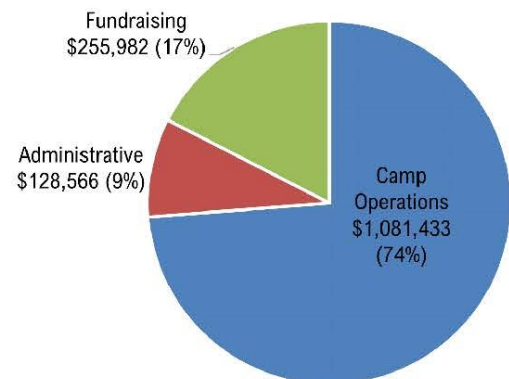

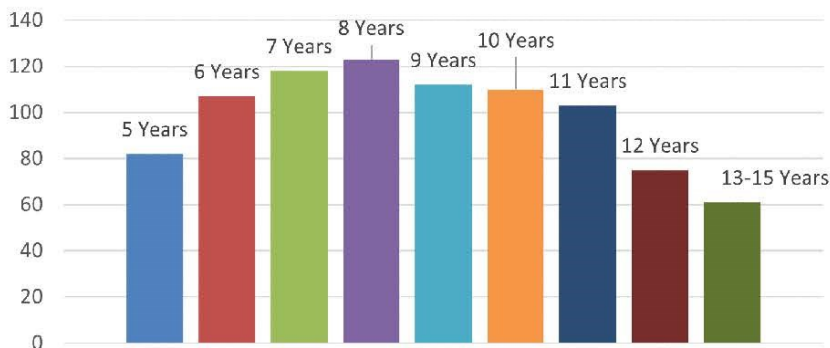

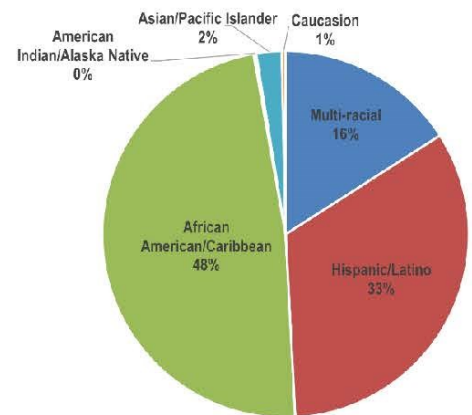

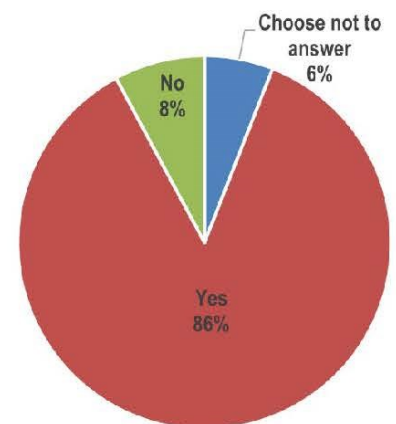

2019 Program Highlights

Girls Empowerment Program

In 2018, Camp staff noticed that several of the female campers, especially those ages 10-12, were reluctant to join in activities with boys present. Girls expressed feeling shy and asked to form their own "club." Camp Courant staff responded by creating the Girls Empowerment Club for the 2019 camp season. The Club provided programming for girls of all ages (5-12) at Camp Courant.

The goals of the Club include:

1. Positive self-image/self-talk
2. Career/college readiness
3. Problem solving/cooperation skills
4. Positive friendship/communication skills

Girls worked with their Program Director to engage in a variety of activities, including field trips to the Harriet Beecher Stowe House, and Central CT State University, as well as a number of women from the Hartford area who came to Camp to share their experiences and presented information about their careers. The girls also participated in a t-shirt design contest and worked together to identify what it means to be a good friend. We look forward to expanding this important program!



Early Learning

Thanks to expanded funding from The Fund for Greater Hartford and United Way, Camp Courant was able to expand the Early Learning Program in 2019, allowing us to serve the most at-risk children ages 5-8 (previously only ages 5-6) with group and one-on-one supports in literacy, numeracy and social-emotional skills. Jennifer Kinell, Program Director, works to complete an assessment with all campers ages 5-8 at the start of the summer. Those children who are identified as most "at risk" following the assessment, receive one-on-one supports as well as group lesson time throughout the six-week camp season. Program staff check in with parents regularly, sharing activities that parents can do with children at home to support their learning. At the end of the summer, campers again complete the early learning assessment so that we can document progress. The expanded Program was a great success. Jennifer wrote, "we had a camper that knew no letters and numbers. At the end of the season she knew 13 letters and sounds and could count to 10." We are grateful for the support from The Fund for Greater Hartford and United Way, which allowed us to serve more children in 2019.
